

A Case Study for Quality Research towards Education System Enhancement in Myanmar

ABSTRACT|: As a case study, this paper has an attempt to investigate the quality research focusing education system enhancement in Myanmar leading to the prosperity of the nation from ten previous researches done by M.A (TEFL) students from Yangon University of Education. It took a month. It was conducted with 'two model approach', part of the multidisciplinary approach by Nuopponen (1994). Self-observation was used as the research tool. Data were collected and analyzed with qualitative research method. Due to the findings, data collections and data analysis of the previous researches done by most of these candidates were very consistent with the research questions, aims and objectives of doing their research. But, there were some necessities in achieving in research aims and objectives in some papers. Nevertheless, all papers accomplished the purposes of doing researches more or less. In brief, all findings from the research will be supportive for further research related to quality research.

Adopting the previous research, in this research paper, by using ‘two model approach’, part of the multidisciplinary approach, the researcher has the attempt to investigate the quality research from ten previous research papers done by ten M.A (TEFL) candidates from Yangon University of Education concerning the development of teaching communicative skills and translation of the students with new English text books prepared consistently with the new curriculum drawn due to the National Strategic Plan. The research procedure and findings of this research will be studied in the next sections.

Master degrees of Teaching English as Foreign Language (TEFL) from Yangon University of Education from 2015 to 2019 in order to observe the quality research on the development in teaching

communicative skills and translation of the students from elementary to tertiary level in EFL classrooms.

Aim and Objectives of the Study

Quality Research

According to Dash, 2009; Grinnell, 2009

“There is broad criticism of the so-called linear model of science, and it is argued that concepts such as intuition and passion have become just as important as objectivity and logic, and there are several very different views on, and definitions of, research practice.”

According to, Jiménez- Contreras al., 2003 wrote:

As the evaluation of research practice is one of our end-goals, we may also need to define what we mean by evaluation. In our view, the practice of evaluation can be defined as an activity in which certain aspects of the quality of research practice are investigated. But what does this really mean? The ambition to evaluate research has a long history that is full of tensions, ambiguities and misunderstandings.

Mathieson, 2005 wrote an often cited definition of evaluation

multidisciplinary approach, there are some methodologies to research practice: working group, concepts modeling and related standards concept modeling and graphical representations, the ‘two model approach’.

Working group

In this activity, there must have a working group that involves four senior researchers with extensive academic experience and one senior modeling expert is formed in a network .The group members must have experience in various research

However “. . .a process for collecting and synthesizing evidence that can make conclusions about the state of affairs, value, merit, worth, significance or quality of a program, product . . each practice”. which implies that evaluation can use numerous methods and mea-sure a wide variety of aspects.

According to the above theories of the respective scholars, a multidisciplinary approach includes multiple disciplines to redefine problems outside of normal boundaries and reach solutions based on a new understanding of complex situations. It is a kind of scientific research method involving the practice of evaluation to extract quality research which is accessible to be applied in research fields.

fields, including medicine, dentistry, computer science, systems sciences, social sciences, educational research, healthcare informatics, management strategy, international business and business modeling. All of the researchers in the group also must have experience of different universities and institutions In order to structure the discussions and the work of the group, concept modeling and an analysis of the concepts related to the quality research. Initially, the goal for the working group was defined, and broad limits of the model were set to include

all relevant concepts for describing and following up research in a multidisciplinary perspective.

Concepts modeling and related standards

According to Nuopponen, 1994, when working towards the goal of trying to find a general model of what research is, it was considered important to define different criteria (or concepts) that can describe the phenomenon of 'research practice'. These criteria should make it possible to separate research from other practices, such as, for example, journalism. Therefore, as an aid to defining the criteria, concept modeling was considered to be a possible way forward. In many respect concept models provide a particularly interesting focus when looking at complex concepts like 'research'. They can be regarded as systems consisting of several components (concepts) and the relations between these components (concept relations). Generally, these models can give us a better understanding of how our work and knowledge are organized, and they often reveal opportunities for simplification and for identifying problems when different professions are interacting. They are fundamental

to information-based organizations and are of special importance to specialists.

Concept modeling and graphical representations

According to Shewchuk et al., 2006, concept models have been developed in several projects where there has been a need to map concepts and knowledge. In Sweden, for instance, the National Board of Health and Welfare has defined the concepts of healthcare and social services by using concept modeling and these concepts are now used by the entire health-care sector. There are also other types of mapping available; for example, cognitive mapping has been used, inter alia, to understand what healthcare journals represent representations

In this method and its notation, concepts are represented as rectangles and associations (attributes) by lines and arrows. Specific concepts are written in italics in the text, and the name of the attribute is to be read in the direction of the arrow. By using cardinality we can make the model more stringent by specifying how the elements of the two concepts interrelate or associate, in terms of:– 1

one and only one– 0.1 zero or one– 1.*
 one or many– * zero or many.

The ‘two model approach’

It is called the concept model and it is used as a reference model that describes what research is in a neutral way, and it can also be seen as a common language about research. This reference model helps us to reason about quality aspects in a methodical way by means of reusing the concepts and their inherent definitions in quality. By describing the quality statements in this way, it is sure that the quality statements are comparable and coherent according to the reference model. There are two phases of this approach: concept model of research and concept hierarchy of research quality and related defined terms_ credible, contributory, communicable, and conforming.




Figure .1 Concept model of research by Nuopponen (1994)




Figure.2 Concept hierarchy of research quality by Nuopponen (1994)

Previous Study of the scholars

According to previous related literature, the scholars named Pär Mårtenssona, a professor from Department of Management and Organization, Stockholm School of Economic, Uno Forsb , a professor from Department of Computer and Systems Sciences, Stockholm University, Sven-Bertil Wallinc, a professor from Department of Marketing and Strategy, Stockholm School of Economics, Udo Zanderd, a professor from Department of Neurobiology, Care Sciences and Society, Karolinska Institute did a research to trace quality research by using multidisciplinary approach. The aim of doing this research was to describe what constitutes research, and then to use this description to develop a model of research practice and to define concepts related to its quality. The

primary objective was to explore such a model and create a multidisciplinary understanding of the generic dimensions of the quality of research practice. Eight concept modeling working seminars were conducted. A graphic representation of concepts and their relationships was developed to bridge the gap between different disciplines. A concept model of research as a phenomenon was created, which included a total of 18 defined concepts and their relationships. In a second phase four main areas were distilled describing research practice in a multidisciplinary context: Credible,

RESEARCH METHODOLOGY

Research Design

To design this research, there are four following facts: sample, instrumentation, and period and research method. The researcher used 'two model approach' part of the multidisciplinary approach to conduct this research.

Sample

In this research, ten previous research papers as theses written by ten candidates who were attending the master degree course for teaching

Contributory, Communicable, and Conforming. Each of these was further specified in a concept hierarchy together with a defined terminology. A comprehensive quality model including 32 concepts, based on the four main areas, was developed for describing quality issues of research practice, where the model of research as a phenomenon was used to define the quality concepts. The quality model may be used for further development of elements weights and operationalization related to the quality of research practice in different academic fields.

English as A Foreign Language (TEFL) at Yangon University of education from 2015 to 2019 were as used as sample.

Instrumentation

In this research, self-observation was used as the research tool.

Research Period

To do this research, it took a month.

FINDINGS

Depending on all data from all ten previous M.A thesis research based on two model approach and responses from interviewing the teaching staff, it was found that it is quite difficult to keep the quality research according to the 'two model' approach that I have earlier mentioned above.

First of all, In accordance with table 2, all data collected from observing ten previous researches based on 'two model' approach were analyzed with qualitative research method. Due to data analysis, eight research papers are credible because all data in these researches are valid, reliable, transparent and consistent with research questions of these papers more or less. But the two other papers listed in No. (5) and No. (10) are not credible because collected

data from these papers are not transparent and reliable with their research questions. Besides, there is no clear validity in data collection and data analysis.

Findings from all research papers except research paper No. (3) and No. (10) are contributory because they are relevant with the aim and objectives of doing these researches. This is because findings from these two papers cannot be said to relevant with aims and objectives of the thesis. Nevertheless, findings from above all listed research papers can be accessible to apply for further researches because they are communicable and searchable. Furthermore, all M.A thesis papers are conforming because data from all of them are justified to ethics, regulations and sustainable. It is found that most of

these theses were consistent with the quality research towards education system enhancement being done by the civilian-led government to some extent.

DISCUSSION

In this research, the researcher collected ten previous researches written by ten M.A (TEFL) candidates attending Yangon University of Education from 2015 to 2019. Of all ten theses, the eight ones were concerned with developing skills and the rest twos are related to teaching aids and translation. In all research papers, the used sample is students from elementary to tertiary level. Now, in Myanmar, the civilian-led government is encouraging to do researches in education sector more than before so that the better and more effective education system can be built up with the well-prepared techniques. The civilian-led government is trying to enhance the education system towards the prosperity of the nation by using National Education Strategic Plan (2016-2021). According to this plan, the national education reforms are being conducted not only for the Basic Education but also for the Higher Education.

Now new teaching curriculums for Basic Education have been drawn and they are being used for Basic Education. English course books and other teaching and learning aids have been upgraded consistently with the internationals. According to above findings from the research, all M.A theses are conforming because data from all of them are justified to ethics, regulations and sustainable so that collected data proved that the new course books and texts prepared with the international norms can lead the education system enhancement and this is focusing the prosperity of the nation. Furthermore, findings from the research show that communicative skills of sample students from the Elementary Level to Tertiary Level in Myanmar could have been improved which can lead to education system enhancement. It will also assist to achieve in drawing the new curriculum and some effective courses designed with the international norms leading to education system enhancement in Myanmar. This will be beneficial to education system enhancement done by the civilian-led government focusing the prosperity of the nation. In brief, it can be said that
